Interest Rates and Interest Charges	
Annual Percentage Rate (APR) for Purchases and Balance Transfers	20.25% or 24.25% when you open your account, based on your creditworthiness. After that, your APR will vary with the market based on the Prime Rate.*
APR for Cash Advances	26.25% This APR will vary with the market based on the Prime Rate.*
How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month.
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$0.70.

How We Will Calculate Your Balance: We use a method called “average daily balance (including new purchases).” See your account agreement for more details.

* The Prime Rate means the highest U.S. Prime Rate as published in the “Money Rates” section of *The Wall Street Journal* on the last business day (Monday through Friday, excluding federal legal holidays) of the month. The Prime Rate current within the last 30 days is 8.50%. We add a margin of either 11.75% or 15.75% to the Prime Rate to determine the APR for Purchases and Balance Transfers, based on your creditworthiness. We add a margin of 17.75% to the Prime Rate to determine the APR for Cash Advances.
